Solicitor's Comments

Jason Brudecki discussed CK COG's suggestion for updated fees and Property Maintenance Code. He suggested getting in-put from Doug Hover. An Ordinance would need to be adopted for the Code update and a Resolution for the new Fee Schedule.

Supervisor Comment

- 1. Supervisor Glenn Troup asked for an update on the reimbursement from Paige Curry. She is paid up until April 2025.
- 2. Supervisor Paul Haines informed the Board that the 2016 Single Axel MAC truck with only 19,000 miles has had multiple problems, and an expense to the Township of \$20,000. to \$30,000. a year. He has names of local people including Susquehanna Motors Salesmen recommending selling the truck and purchasing a 2007 truck without computers and emissions controls.
 It was suggested by several residents that a complaint be filed with MAC through a Zone Representative,
