Expenses

Glenn Troup made a motion, to approve the Secretary/Treasurer to pay the May expenses, on a weekly basis with Supervisor approval. Todd Oberdorf seconded with the exception of Cannon Road Project expenses including labor, as he feels the project was too big and should have been voted on and discussed at a public meeting. The Road Master explained that he called the Assistant Supervisor for approval after Leroy Troester volunteered to pay for all of the amiesite for the project, 300' for the road and 20' for his driveway.

Todd Oberdorf also questioned if there was a Sunshine Law Violation because this was discussed by two Supervisors outside of an open meeting and it was way over the amount of money you can spend on one project.

Todd Oberdorf said that he doesn't think that we should be billing Leroy Troester anything for this and doesn't know how legally we can, since we don't pay tax on it and we are not in the business to resell a product. Paul Haines said that we are not making money on the project. Todd said that doesn't matter. We got the amiesite at a Government discount since we bid it out and should not be reselling it. A resident asked what amount was paid to the Township and was told that he was not billed yet since we had just received the bill ourselves.

The Solicitor said there was a problem as the Township cannot do work on private property and called for an Executive Session.

Public Comment Non-Agneda Items

- 2. One resident questioned what the budget was and what the labor costs were for the Cannon Road Project and who was paying for it. The Road Master said that there was no budget for the repair as only larger projects are budgeted. The labor costs have to date not been figured as pay roll for last week was not completed. The Resident of the property in question on Cannon Road agreed to pay the entire cost of the **amiesite** for the entire project not payroll.
- 3. Another resident asked if the Township can legally bill for the work done on the resident's driveway. The Solicitor said that it cannot. It was suggested that the Road Master pay. The Solicitor said If the resident doesn't pay the Township will. He said that is why the action was taken after the Executive Session.
