9. Glenn Troup Resignation

Todd Oberdorf made a motion, seconded by Paul Haines to accept the resignation from Glenn Troup due to health issues.

A resident asked about the change on the Financial Report for the General Fund Account. The
usual Account Balance is the monthly Bank Statement. There has been an addition of "Ledger
Balance" which is ALL of the activity withing said month, cleared or uncleared at the bank, which
was requested by residents.

Solicitor's Comments

Regarding Glenn's resignation the filling of vacancies of elected Township offices, is governed by Article IV of the Second Class Township Code. Section 407 covers the procedure for a vacancy in an elected office.

- 1. The Board of Supervisors must accept a tendered resignation within 45 days of it being tendered, unless it is withdrawn in writing prior to acceptance
 - a. The resignation will be deemed accepted if the Board fails to accept the resignation within the 45 days
 - b. The vacancy cannot be filled until the resignation has been accepted, which we will be doing tonight
- 2. The Board of Supervisors <u>may</u> appoint a successor to fill the vacancy the successor must be a Township resident that has lived in the Township continuously for a least one year prior to appointment if Paul and Todd are in agreement on an appointment, the two of them can decide who fills Glenn's seat
- 3. The Board of Supervisors has 30 days from the date the resignation is accepted to fill the vacancy failure to do so gives the Township "vacancy board" the opportunity to fill the position.
 - a. The Township Vacancy Board consists of the Township Supervisors (i.e., Paul and Todd) and one registered elector (i.e., resident) who shall serve as chairperson of the Vacancy Board, who was appointed at the January Reorganization Meeting. In this case, that person is Will Zimmerman.
 - b. The Vacancy Board would have 15 days to fill the vacancy.
- 4. If the Vacancy Board fails to fill the vacancy within 15 days, the Township would have to petition the Court of Common Pleas to fill the vacancy.

Bottom line: Paul and Todd have 30 days to agree on someone to appoint. If they cannot, the Vacancy Board would have 15 days to appoint someone.

As far as the term of the appointment, the person selected would be in Glenn's seat until January 5, 2026. We will need to contact the County Department of Elections regarding the vacated seat and the vacated seat should appear on the ballot for this November's election.
