

## Buffalo Township Municipal Sewer Authority Meeting

Under citizen's concerns: Harvey Sensinig talked to us about purchasing part of out land at the Beaver Run pump station. He brought a map to show what he wanted. After much discussion, we decided that we would prefer not to sell. We are recommending an easement.

Linda Troup made a motion to accept the Treasurer's report as presented. It was seconded Bob Sampsell. All approved.

Under Engineer's report: Josh Satteson gave update on Black Run pump station Rehab project. Bib Sampsell made a motion to have Seda-Cog reimburse Sewer Authority for HRG invoice #188631 in the amount of \$21,750.00 for the Black Run Pump Station Rehab Project. It was seconded by Brian Zettlemoyer. All approved. Linda Troup made a motion to have Seda-Cog pay both HRG invoice #190498 in the amount of \$3,573.00 and HRG invoice #192710 in the amount of \$397.00 for the Black Run Pump Station Rehab Project. It was seconded by Brian Zettlemoyer. All approved.

Under Operator's report: Todd Oberdorf talked about the problem with junk on lane to Buffalo Cross Roads pump station. We need to find out if we own lane or have easement. Todd also discussed the force main at the Beaver Run pump station. We are not sure where it is. Josh Satteson suggested GPR to find it. Todd will get prices on that and digging it up.

There was nothing under delinquent bills.

Under old business: Lena Baumer gave update on debit/credit card. She will discuss details with Mifflinburg Bank again.
